- 2. The total price should be given in words and figures at price schedule and should be valid for a period of 49 days from the date of Quotation opening.
- 3. The unit price quoted should be net price (i.e. Less discount if any) without VAT. Any other taxes should be included to the unit price. Please indicate VAT component separately with your VAT registration number if any. If not VAT component will not be paid. Evaluation will be done without VAT. All facilities provided by the Supplier which effect to unit price should be given in the price schedule.
- 4. The Price schedule shall be signed by the Supplier or any other person authorized by him.
