

General Conditions

1. Obtain the valid license to use the waste management park at kerawalapitiya as a waste management site yearly (Application format is available in Annexure – 01).
2. A nonrefundable payment should be paid as application fee to be made to the Sri Lanka Land Development Corporation directly to cashier or deposited to the account no 3270388, Bank of Ceylon, Rajagiriya Branch.
3. The license valid until 31st December each year and must be renew for the next year one month prior to expire the license.
4. Compulsory to submit a signed copy of the License within 3 days after the date of issuing the license.

Condition for Waste Disposal

1. Waste Management Park at Kerawalapitiya is accepted segregated waste only. Acceptable waste categories are as follows.
 - Degradable Waste (Kitchen & Garden Waste)
 - Polythene & Plastics
 - Glass
 - Metal
 - Coconut Shell/ Fuel Wood
 - Cloths
 - Cardboard/ Papers
 - Electronic Items
 - Pampers are not accepted at any cost
2. Charges will be applicable as weight basis and Rs. 3,589.74 + VAT will be charged per metric ton of waste.
3. Waste should be transported in covered trucks and care should be taken to avoid environmental hazards from leakage of leachate from the transporting vehicles and any disturbances to the public during waste transportation.
4. Waste Transporting vehicles need be registered before entering the site. If not vehicles are not allowed to enter the site. If any vehicle not in the initial registration, vehicle number should be informed via email (sllrdc.wastepark@gmail.com) before reach the site. For the container disposal, vehicle numbers should be informed us via

email (sllrdc.wastepark@gmail.com) one working day prior (before 4.00 pm) to dispose.

5. The attached format with the original license should be filled by the authorized officer and send along with the waste transporting vehicle to the site.
6. The site will be operating within 8:00 AM to 5:00 PM only. If you are unable to reach within permitted time, the vehicles are not allowed to enter in to the site.
7. For container disposal, vehicles should reach the site on or before noon on weekdays and relevant officials should participate to monitor the disposal process at site.
8. The rejected material (container disposal) from other organizations (SL Customs, SLSI, MEPA or other) need to get prior approval by submit a written request (Annexure – 02) prior to five working days.
9. Weight of the waste will be measured by using the weighbridge at site. When the weighbridge is not in operation, previous month average (vehicle no basis or load basis) will be used for vehicles and container need to submit the weighing bill from nearest weighbridge.
10. If the waste quantity is less than one metric ton per load, it will be charged as one metric ton.
11. If you require any additional machinery for unloading purpose, relevant machinery charges should be paid separately at prevailing rates. The machine requirement needs to inform us in advance.
12. Necessary labourers need to be arranged for container waste unloading, by your side.
13. Payment should be settled at the time of disposal/ within 30 days after issuing the invoice as mentioned in the license.
