### **Terms and Conditions**

1. Applications for Registration of suppliers & Contractors can be downloaded from the web site ([www.landdevelopment.lk](http://www.landdevelopment.lk)) of the SLLDC free of charge.
2. A prospective supplier who wishes to get registered for supply and services should pay a non - refundable registration fee Rs. 2,500.00 for each main category. The method of payment will be direct cash deposit to **Account No 3271113**, Account Name- Sri Lanka Land Development Corporation, Bank and branch- Bank of Ceylon, Rajagiriya Branch or can pay to the cashier in Finance Division by cash. 3. Along with the duly filled application a copy of business registration, NIC Copies of Owners, Form for List of Director names to Private Limited Companies, VAT registration & the Original payment receipt. Should be submitted. For civil contractors CIDA registration certificate should also be submitted.
4. The applicants who are the manufacturer/owner of the registered trademark of the product or Trade mark owners or sole agent, the authorization letter issued by principal or relevant authority must be attached.
5. Documents for Registration of Suppliers & Contractors could be submitted to Supplies Division of SLLDC on any working day until 31st December, 2024 between 9.00 a.m. to 3.30 p.m.
6. Registration may involve inspection in the Business premises if necessary, to ascertain whether applicant is a genuine dealer of the item/items for which registration is/are sought.
7. Quotations will be invited generally from the registered suppliers for supplies but the SLLDC reserves the right to invite quotations from other suppliers who are not registered and to effect purchases.
8. The applicant should agree and have the capacity to provide a credit period of minimum of 30 days in the event he/she is being selected for supply of goods.
9. Registered suppliers who fail to quote when offers are invited or who fail to deliver goods and services in time when orders are placed or who supply items which are not in conformity with required specifications are liable to be deleted from the Register of suppliers without notice.
