1.1. Introduction

The Real Time Flood Control Centre of the Sri Lanka Land Development Corporation (SLLDC) has one of its most important computation and data storing processes established in the Google Cloud Platform (GCP), and this system has been storing data real time from 50 automated weather stations situated island wide, mainly in the Kelani River Basin and 33 automated water level stations installed in the Colombo canals and on the Kelani River. The system also houses the data quality checking procedures, archival of backup data, and websites related to Integrated Flood Management System (IFMS). Using the established system, the IFMS is providing decision support for flood controlling.

Since SLLDC is not capable of directly paying to the GCP in USDs, it is currently looking to procure the services of a payment partner to pay for the GCP in USDs, and the SLLDC shall pay the payment partner in LKR, on monthly basis.

1.2. System Specification

The system is consisting of 4 Virtual PCs and its computational infrastructure including storage, memory and networking, as described below.
