The Chairman – Procurement Committee, Sri Lanka Land Development Corporation (SLLDC) under the Ministry of Urban Development, Construction and Housing intends to invite sealed Bids from eligible and qualified Bidders to indicate their interest for renting of space at Diyatha Uyana to operate a Trackless train.

Scope of the Bid

- (i) The contract consists of renting of space for operating a Trackless train at Diyatha Uyana.
- (ii) The selected bidder shall supply, installed and manage the train operation with a trained staff, ensuring a safe and enjoyable experience for all visitors
- (iii) Bidding shall be conducted though National Competitive Bidding [NCB] Procedure.
- (iv) The contract period is one [01] year and can be extended up to three [03] years if SLLDC wish to extend based on the performance of the selected bidder.
- (v) Shall comply with safety regulations and accessibility standards for all age groups, including children and individuals with mobility impairments.
- (vi) The operation of the train shall be limited to the area specified in the Contract Data and Location details.
- (vii) Shall regularly maintain the train and associated equipment.
- (viii) Shall carry out eco-friendly operations and noise control measures while ensuring minimal disruption to other activities at the park.
- (ix) The selected bidder may construct a mobile ticket counter of maximum plan area of 20 Sq.ft. The design of the ticket counter shall be approved by SLLDC and shall align with the architectural features of Diyatha Uyana.

The method of payment shall be only in cash.
- 2. Bids shall be delivered with duplicate to the following address **on or before**13.30 hrs on 24.01.2025. Late Bids shall be rejected. Bids shall be opened soon after closing in the presence of the Bidders representative who chooses to attend.

2. Scope of Bid

3. Qualification Criteria

Bidder shall have a valid business registration related to similar activities Preference will be given for bidders with experience in operating trackless trains or conducting similar recreational activities in last five (05) years.

4. One bid per Bidder

Each Bidder shall submit only one Bid. A Bidder who submits or participates in more than one Bid shall be disqualified.

5. Cost of Bidding

Bidder shall bear all cost associated with preparation and submission of Bids.

6. Language of the Bidding Document shall be **"English".**

7. Bid validity:

Bids shall be valid up to 28.03.2025.

8. Bid Security

All Bidders shall submit a Bid Security of **Rs. 25,000/=** along with the Bid.

It may be a cash bond or a security in the form of Bank Guarantee from a licensed commercial bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka. This Bank Guarantee shall be irrevocable and unconditionally encashable upon the first written demand from the Employer. (The Specimen Form is depicted in Standard Forms)

If the Bid Security is a cash Bond, Bidder shall pay the amount to the cashier at SLLDC head office at Rajagiriya and the <u>original payment receipt shall be attached with the Bid.</u>

Cheques or any other forms of payments shall not be accepted.

Validity of Bid Security

Bid Security shall be valid up to 25.04.2025.

11. Format & Signing of Bid

All fillable pages of the Bidding documents shall be signed and sealed by the Bidder.

12. Sealing and Marking of Bids

Duly filled bid packages (one Original & one Duplicate) separately shall be submitted under one sealed cover in which the Bids are enclosed shall be marked "Renting of Outdoor Space to Operate a Trackless Train at Diyatha Uyana" on the left hand corner of the cover.

13. Deadline for Submission of Bids

The deadline for submission of Bids shall be 24.01.2025 at 13.30 hrs.

Bids shall be sent under registered post to the following address or deposited to the identified tender box available in the Supplies and Stores Division of SLLDC on or before the dead line.

14. Evaluation Criteria

Information relating to the examination, clarification, comparison and evaluation of bids and recommendations for the award of contract shall not be disclosed to bidders. Any effort by a bidder to influence SLLDC's processing of bids or award decisions may result in the rejection of the Bid.

- 15. The successful bidder shall be issued a Letter of Acceptance.
- 16. The Bid security of all Bidders shall be refunded/ returned after awarding the Contract to the Selected Bidder and after the receipt of the Refundable Deposit from the Selected Bidder or after the bid validity period, if not extended by SLLDC.
- 17. Duly filled Form of Bid, Price Proposal, and SECTION III Standard Forms are mandatory submissions. Bids without these documents shall be rejected.
- 18. Copies of National Identity Card of the Bidder and other related documents shall be forwarded along with the Bid.
- 19. The Chairman- Procurement Committee of SLLDC reserves the right to accept or reject any bid and has the discretion to annul the bidding process, rejecting all bids at any point before the award of the contract. This action does not incur any liability towards the affected Bidder, nor does it impose an obligation on SLLDC to provide information to the affected bidder regarding the grounds for the decision.

SECTION II - CONTRACT DATA

1. Definitions

- 1.1. Employer: General Manager, Sri Lanka Land Development Corporation

- 1.3. The Works consists of: Renting of outdoor space at Diyatha Uyana to operate a Trackless train.
- 1.4. Location of the Site: Diyatha Uyana, Battaramulla Length of the track: 200m



2. Scope of the Work

- i. The contract consists of renting of space for operating a Trackless train at Diyatha Uyana.
- ii. The selected bidder shall supply, install and manage the train operation with a trained staff, ensuring a safe and enjoyable experience for all visitors
- iii. Bidding shall be conducted though National Competitive Bidding [NCB] Procedure.
- iv. The contract period is one [01] year and can be extended up to three [03] years if SLLDC wish to extend based on the performance of the selected bidder.
- v. Shall comply with safety regulations and accessibility standards for all age groups, including children and individuals with mobility impairments.
- vi. The operation of the train shall be limited to the area specified in the Contract Data and Location details.
- vii. Shall regularly maintain the train and associated equipment.

- viii. Shall carry out eco-friendly operations and noise control measures while ensuring minimal disruption to other activities at the park.
 - ix. The selected bidder may construct a mobile ticket counter of maximum plan area of 20 Sq.ft. The design of the ticket counter shall be approved by SLLDC and shall align with the architectural features of Diyatha Uyana.

3. Contract Period

SLLDC shall lease the space of the Selected Bidder for one [01] year and can be extended up to three [03] years at SLLDCs sole discretion based on Bidders performance throughout the contract period assessed by SLLDC.

Selected Bidder shall initiate the operation of the trackless train within 60 days of the date of Letter of Acceptance.

4. Payment Method

Selected Bidder shall make payments monthly as depicted in the Price Proposal on or before seventh day of each month from the start date (payment due date).

5. Mechanism of payment

Rate applicable for the second year shall be 110% of the price quoted for the first year by the Selected Bidder and for the third year rate applicable shall be 110% of the rate applicable for the second year. Payments shall be made by the Selected Bidder to SLLDC on monthly basis.

In case where SLLDC at its sole discretion extend the Contract Period after 3 years, and a new agreement shall be signed in such instances.

6. Refundable Deposit

Selected Bidder shall submit a Refundable Deposit of Rs.500,000.00 within seven (07) days after receiving the Letter of Acceptance.

It may be a cash bond or a security in the form of Bank Guarantee from a licensed commercial bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka. This Bank Guarantee shall be irrevocable and unconditionally encashable upon the first written Demand from the Employer. (The Specimen Form is depicted in Standard Forms). The such Bank Guarantee shall be valid up to 3 years from the date of Latter of Acceptance.

If the refundable deposit is a cash Bond, Bidder shall pay the amount to the cashier at SLLDC head office at Rajagiriya.

The Refundable deposit shall be released after the end of Contract Period after deducting for damages to the property. (if any).

If SLLDC shall extend the contract period, validity period of Refundable deposit shall be extended as per the extended contract period.

The SLLDC holds the right to forfeit this deposit either <u>at least one</u> of following circumstances occurs.

- (I) If the selected bidder withdraws from the operation within the contract period after accepting the letter of acceptance.
- (II) If the selected bidder fails to pay the monthly payments even after 30 days from the payment due date
- (III) If the Selected Bidder violates Terms and Conditions stated in terms and conditions mentioned in clause 6 or 8
- (IV) At the termination of the Contract any damages to the property of SLLDC for which the Selected Bidder is responsible, this security deposit shall be used to recover the cost of such damages.

7. Terms and Conditions

- 1. Selected Bidder shall operate the trackless train without disturbing the other activities of the park. Further disposal of garbage, oil is strictly prohibited.
- 2. A charging point (a single phase line only) for the train will be provided near the Island Stage as depicted in the 1.4 above. Electrical material required for the connection and an electricity meter shall be supplied by the selected bidder at its own cost. All the utility bills shall be paid by the Selected Bidder to SLLDC on monthly basis. SLLDC shall send separate invoice to the Selected Bidder for the utility bills.
- 3. Monthly rental and the utility bills (electricity) shall be settled on the due date. If the monthly rental is delayed, a surcharge of 0.067% of the monthly rental shall be charged per day with effect from payment due date.
- 4. If SLLDC decides to terminate the contract due to any violation of Terms and Conditions or illegal activities by the selected bidder, or if SLLDC chooses not to renew the contract after the contract period, SLLDC shall not be responsible for any costs incurred by the selected bidder. Additionally, the selected bidder shall not claim any expenses related to the train from SLLDC.
- 5. A penalty of Rs.5,000/- will be charged for dishonored cheques.
- 6. If the selected Bidder fails to pay the monthly rental within 07 days from payment due date, SLLDC has the right to disconnect the electricity connection. And if the Selected Bidder fails to make the payments within 30 days from the payment due date, SLLDC holds the sole right to terminate the Contract with Selected Bidder and to forfeit the Refundable Deposit submitted by the Selected Bidder.
- 7. At the termination, due monthly rental, utility bills and wear and tear expenses shall be settled by the Selected Bidder.

- 8. SLLDC reserves the right to terminate the contract and forfeit the refundable deposit without prior inquiry in the event of any violation of Terms and Conditions, involvement in illegal activities, or occurrence of a major accident.
- 9. Selected Bidder is subject to an Agreement with SLLDC soon after issue of Letter of Acceptance.
- 10. Selected bidder shall obtain necessary approvals from relevant authorities and for the operation of the trackless train.
- 11. Selected bidder shall obtain All Risk Insurance Policy coverage with every aspect for the trackless train operation (Minimum coverage Rs.1 million). Selected Bidder shall submit the insurance policy coverage certificate to SLLDC within 1 week from the date of Letter of Acceptance.
- 12. Selected Bidder shall be liable for any damages caused to the demised premises. Any such damage caused shall be estimated by the Site Engineer of SLLDC and shall be informed to the selected Bidder. The selected Bidder is bound to pay such estimated damage.
- 13. Selected Bidder shall keep the demised area clean and tidy.
- 14. Selected Bidder shall use the premises exclusively limited for the purpose which it is leased.
- 15. Selected Bidder shall not be permitted to sub-let or sub lease the operations of the train to any third party.
- 16. The selected bidder may cover the trackless train from suitable clothing at non-operational hours and construction of shelters is not permitted.
- 17. Trackless train operational hours shall be within 8.00am to 10.00 pm.
- 18. The selected bidder shall not have the sole right to use the permitted track (asphalted road stretch). Other recreational service providers too shall use the same.
- 19. SLLDC shall conduct other recreational activities/events at Diyatha Uyana, The selected bidder shall not obstruct any such activity.
- 20. In case of events at the permitted operational area, SLLDC shall request the selected bidder to shift the path of operation of the train. In such case, the selected bidder shall adhere to the instructions provided by SLLDC.
- 21. The selected bidder shall adhere to the rules and restrictions imposed by the SLLDC site engineer.
- 22. Selected bidder shall obtain prior approval from SLLDC regarding display of brands (if any) of the train and shall be subjected to additional payments.
